 - Eliquis
 - Pradaxa
 - Clopidogrel, Clopiwin, Clopidogrel, Plagrol, Plavix
 - Brillinta, Effient
- Please inform us if you are a patient with diabetes using insulin.
- You do not need to advise us in advance if you are on aspirin (Disprin).
- Please bring a copy of your latest prescription. Alternatively bring all your prescription medication to hospital, preferably in original packaging.
